

# Ilsington Village Shop Association Limited Community Award 2016

### Thank you for your enquiry.

The Ilsington Village Shop Association has been set up as a not for profit Registered Society.

IVSA management committee will propose to members on an annual basis the level of funding available for funding activities that benefits the llsington community.

For 2016 there will be a total of £3,000 awarded of which £500 has already been allocated.

The IVSA Awards Sub-committee will convene annually to invite applications from organisations that meet the requirements of the selection criteria. The sub-committee will collect the completed applications and will decide whether a ballot is needed to decide which activities will receive support.

Awards will be made based on the following criteria:-

#### Criteria

IVSA Community Fund awards will usually only be considered from open membership clubs, groups, associations, charities or from a cause that has the majority support of IVSA members.

The application shall demonstrate the need for funds and quantify the benefits that the activity will bring to the community.

The organisation or cause must be able to ensure that the funds will be spent appropriately.

#### **Excluded projects/activities**

The project/activity shall not be deemed to be promoting a particular religion or faith group.

The project/ activity shall not be deemed to be supporting, fundraising, campaigning or any other activity associated with any political party.

#### Applications.

Applications for funding should be made on the attached application form. This must be completed in full in all cases and be submitted to the IVSA Secretary by the application closing date of 22<sup>nd</sup> July 2016

The IVSA Awards Sub-committee will check the applications for eligibility and present a list to IVSA members who will decide on the winners by majority vote.

It is intended that awards will be made in October 2016.
